COMMUNICATION

1. The DCAA Administrator or a DCAA CSBG Program Manager will attend and report on the DCAA's programs at all Iowa Community Action Association Board of Directors' meetings. The report will include a CSBG CARES Supplemental update.
2. At least one DCAA CSBG Program Manager will attend and present a CSBG program report at all Iowa community action agency ROMA Subgroup meetings. The CSBG program report will include a CSBG CARES Supplemental update.

3.2. Eligible Entity Involvement: Describe the specific steps the state took in developing the CSBG CARES Supplemental State Plan to involve the eligible entities.

The following are the steps the Division of Community Action Agencies (DCAA) took to involve the Iowa Community Action Association (ICAA) and Iowa's community action agencies in the development of this CSBG CARES Supplemental State Plan:

Prior to the release of the State Plan application for CSBG CARES Act funds, the DCAA Administrator and DCAA CSBG Program Manager provided CSBG CARES Supplemental information to ICAA and the agencies as it was made available. This included providing CSBG Information Memorandums, CSBG Dear Colleague Letters, invitations to HHS/OCS and National Association for State Community Services Programs (NASCSPP) webinars, and federal and state guidance documents related to the CSBG CARES Supplemental.

Through electronic meetings and conference calls in April, May, and June, the DCAA Administrator and DCAA CSBG Program Manager reviewed and had planning discussions with ICAA, the agencies' Executive Directors, and/or CSBG staff on the following CSBG CARES Supplemental topics:

- Purpose and use of funds
- Procedures for distributing and allocating the funds
- Procedures for releasing available funds
- Client eligibility criteria and determinations
- Procedures for issuing contracts and applications
- Reporting and processing expenditures of funds

August 6, 2020: The DCAA Administrator and DCAA CSBG Program Manager attended ICAA's Board of Directors' meeting. The CSBG Program Manager provided information about the Supplemental State Plan, the DCAA's Supplemental State Plan development process, and reviewed the Supplemental State Plan development and submittal timeline.

August 7, 2020: The DCAA distributed, by e-mail, copies of the Supplemental State Plan and a document that summarized each section of the Supplemental State Plan to ICAA, the agencies' Executive Directors, and ROMA Subgroup members. The DCAA directed ICAA, the Executive Directors, and ROMA Subgroup members to review the Supplemental State Plan and submit comments to the DCAA during the public inspection period.

Prior to the DCAA submitting the Supplemental State Plan to the Office of Community Services, the Iowa Commission on Community Action Agencies (the DCAA's governing body) reviewed the Supplemental State Plan, acted on it during their August 20th meeting, and approved it for submission.

Section 4: CSBG Hearing Requirements

Iowa's CSBG CARES Supplemental State Plan public inspection period was from August 7, 2020 through August 19, 2020. On August 7th, the Division of Community Action Agencies (DCAA) distributed, by e-mail, copies of the Supplemental State Plan and a public inspection notice to the Iowa Community Action Association (ICAA) and all of Iowa's community action agencies. The public inspection notice informed interested persons, partners, and stakeholders of the Supplemental State Plan's purpose and that the Supplemental State Plan was available on the DCAA, ICAA, and agencies' websites. Persons, partners, and stakeholders wanting to comment on the Supplemental State Plan were directed to send their comments, by e-mail, to the DCAA. The DCAA, ICAA, and the agencies posted the public inspection notice on their public bulletin boards and websites.

The DCAA reviewed and discussed the Supplemental State Plan, including the public inspection comments received, with the Iowa Commission on Community Action Agencies (the DCAA's governing body) during their August 20th commission meeting. The commission acted on the Supplemental State Plan during that meeting.

The following are Iowa's CSBG program procedures for allocating Iowa's CSBG allotments to Iowa's community action agencies. Iowa uses a **FORMULA + FLOOR** allocation method:

- Step 1: FORMULA:** 96% of Iowa's CSBG allotment is allocated to the Iowa community action agencies using state poverty data. Iowa's poverty data (individuals at or below 125% of the U. S. Department of Health and Human Services Poverty Guidelines) from the U. S. Census Bureau's 2010 decennial survey is used to calculate each agency's percentage of the state's poverty population.
- Step 2: FLOOR:** Iowa's CSBG minimum allocation level for agencies is \$160,000. After the CSBG funds are allocated to the agencies using state poverty data (Step 1), the agencies with an allocation amount lower than \$160,000 are identified and their allocation is raised and set at \$160,000.
- Step 3: SUBSIDIZING THE FLOOR:**
- 1) The amount of CSBG funds needed to raise agencies to the FLOOR is calculated. This is the subsidy amount.
 - 2) Agencies that had an increase in their percentage of the state's poverty population, calculated using the data from the U. S. Census Bureau's 2000 and 2010 decennial surveys, subsidize the FLOOR. The subsidy shares for each agency required to contribute to the subsidy are calculated and then their allocation is reduced by the amount of their subsidy share. The following are the four agencies that contribute to the subsidy and the percentage of the subsidy (share) they are responsible for: IMPACT Community Action Partnership (60% of the subsidy), Hawkeye Area Community Action Program (26%), Mid-Iowa Community Action (9%), and Community Action of Southeast Iowa (5%).
